First Visit Checklist

- Make sure your dog is in good health (no sneezing, wheezing, runny nose, etc..)

- Bring a copy of your dogs vet records with proof of Rabies, Distemper and Bordetella vaccines. They can also be faxed to us at 952.922.8147. If you are not sure if your dog has all the required shots, just call or email us and we can help you out.

- Fill out the Owner Agreement and Owner Release form.

- Schedule your evaluation time either on our website or by calling 952.922.8183. Evaluations may be done on Monday, Tuesday, Wednesday, Saturday and Sunday from 9am-4pm. Dogs may be left longer than 2 hours, we just ask that you are available to pick up your dog in the first 2 hours if needed. We charge our daycare rate for the evaluation (\$5 per hour or \$26 for the day). **We DO NOT do evaluations on Thursday and Fridays.**

- When you come in, keep your dog on the leash. If you would like we can give you a tour of our building, but will not visit the play areas as this can be stressful on the dogs that are there, and increase barking (which we work very hard at controlling). We do have a monitor in the lobby where you can watch the webcams and you can also watch the webcams at your house, work or on your cell phone.

- Tell your dog to get ready to have a great time at Pampered Pooch Playground! We can't wait to meet you and your pooch!!

Owner Agreement and Release Form

_____ 1. Payments are due at the end of each day for attendance at Pampered Pooch Playground, LLC. Updated rates are posted in the lobby and at pamperedpoochplayground.com. If a dog is dropped off for daycare service, it will be assumed that the dog will be picked up before the posted close time, if a dog is dropped off for hotel service, the customer will provide a pick up date. If a dog has not been picked up 3 days after the scheduled pick up date, and the owner can not be contacted the dog will be considered abandoned. (This abandonment policy is required by the State of Minnesota).

_____ 2. Payment may be made by cash or Visa/MasterCard/Discover/American Express. Any discounted packages must be paid in advance and are non-refundable. Packages will expire 6 months from date of issuance.

_____ 3. I understand that I am solely responsible for any harm or damage caused by my dog(s) while attending Pampered Pooch Playground. I further agree to indemnify Pampered Pooch Playground, LLC, its owners, staff and volunteers for any loss, liability, damage, or costs they may incur due to any harm caused by my dog(s).

_____ 4. I agree and understand that any problems that develop with my dog(s) will be treated as deemed best by Pampered Pooch Playground, in their sole discretion, and that I assume full responsibility for any and all expenses involved. I authorize Pampered Pooch Playground, LLC to contact the veterinarian indicated on the Enrollment Form in the event of an emergency to provide appropriate medical treatment to my dog(s) if I am unable to be contacted. I understand that the cost of any such treatment will be my responsibility. I authorize veterinary expenses not to exceed the amount of \$ _____. In the event the veterinarian listed on the enrollment form is unable to be contacted, I authorize Pampered Pooch Playground management to take my dog(s) to another veterinarian should circumstances warrant it. If no amount is filled in, the amount authorized will be \$1000.00.

_____ 5. I agree and understand to indemnify Pampered Pooch Playground, LLC, its staff, and volunteers for any loss, liability, damage, or cost they may incur due to my dog(s) participation and attendance in the daycare/hotel.

_____ 6. I agree and understand that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the law of the State of Minnesota and if any portion thereof is held invalid, it is agreed and understood that the balance shall continue in full legal force and effect. Should a court determine that any provision waiving liability is deemed unenforceable, Pampered Pooch Playground, LLC liability shall be limited to the funds paid to it by me for taking care of my dog(s).

_____ 7. I agree and understand that in admitting my dog(s), Pampered Pooch Playground, LLC has relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggression or threatening behavior toward any person or any other dog.

_____ 8. Pictures or videos might be taken of my dog while playing and used for marketing purposes.

_____ 9. I understand that a bark collar might be used on my dog if my dog does not react to other forms of bark control methods. (We try to use every method possible before a bark collar is used on the dog, and we also will try to inform the owner of the use. Out of control barking can stress out other dogs and employees, so every effort is made to control barking. Should you have questions about the use, please ask the Pampered Pooch Playground staff).
